

**PREMIUM REIMBURSEMENT PLAN OF THE  
VENTURA COUNTY PROFESSIONAL FIREFIGHTERS' ASSOCIATION BENEFIT TRUST**

**SUMMARY ANNUAL REPORT**

This is a summary of the annual report for Premium Reimbursement Plan of the Ventura County Professional Firefighters' Association Benefit Trust (Employer Identification No. 95-6107981, Plan No. 501) for the year ended June 30, 2022. The annual report has been filed with the Department of Labor's Employee Benefits Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Health insurance premium reimbursement benefits for retired participants, as defined by the Plan document and Trust agreement, are provided by contractual contributions from the County of Ventura, and contributions from participants who retire without the required number of years under the plan and from prior members who have been promoted to management.

**BASIC FINANCIAL STATEMENTS**

The value of plan assets, after subtracting liabilities of the plan, totaled \$16,539,647 at the end of the year compared to \$16,891,561 at the beginning of the year. During the year the Plan experienced a decrease in net assets of \$351,914. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of plan assets at the end of the year and at the beginning of the year or the cost of assets acquired during the year.

The Plan's income totaled \$734,528 for the plan year, of which contributions from the County of Ventura were \$1,034,934, contributions from those promoted to management positions were \$15,820, realized loss from the sale of investments was \$3,174, and investment loss was \$313,052. The Plan's expenses were \$83,586 for administrative and \$95,200 for investment management and custody expenses. Benefits paid to retired beneficiaries were \$907,656 for the year.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
